

# Terms of Use

Version 0004.4. Last updated: 10/01/2021

This agreement applies between you, the User of this Web Site and LinkiBag, the owner(s) of this Web Site. Your agreement to comply with and be bound by these terms of use is deemed to occur upon your first use of the Web Site. If you do not agree to be bound by these terms of use, you should stop using the Web Site immediately.

You agree that by accessing the Web Site, you have read, understood, and agree to be bound by all of these terms of use. If you do not agree with all of these terms of use, then you are expressly prohibited from using the Web Site and you must discontinue use immediately.

Supplemental terms of use or documents that may be posted on the Web Site from time to time are hereby expressly incorporated herein by reference. We reserve the right, in our sole discretion, to make changes or modifications to these terms of use at any time and for any reason.

## Definitions and Interpretation

In this Agreement the following terms shall have the following meanings:

**“Content”** means any web links, text, graphics, images, audio, video, software, data compilations and any other form of information capable of being stored in a computer that appears on or forms part of this Web Site;

**“User” / “Users”** means any third party that accesses the Web Site and is not employed by LinkiBag and acting in the course of their employment; and

**“Web Site” or “Website”** means the website that you are currently using ([www.linkibag.com](http://www.linkibag.com)).

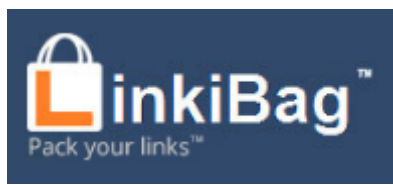
**“Inbag”** means Inbox type of web folder where users find received web links shared by other users accepted as a 'friend'

**“LinkiDrops”** means advertisement web links added by LinkiBag to users Inbag and other folders to promote products of services of paid advertisers.

## Acceptance of Terms of Use

Certain areas of the Service may be subject to additional terms of use that we make available for your review. By using such areas, or any part thereof, you are expressly indicating that you have read and agree to be bound by the additional terms of use applicable to such areas. In the event that any of the additional terms of use governing such area conflict with these Terms of Use, the additional terms will control.

The Privacy Policy, together with these Terms of Use, and any other terms contained herein or incorporated herein by referenced, are collectively referred to as the “Terms of Use.” The term “using” also includes any person or entity that accesses or uses the Service with crawlers, robots, data mining, or extraction tools or any other functionality.

### **About the Service**

The Service is a platform that provides technologies and services that enable people to connect with each other, build communities, and share web links with or without personalized comments. You can save websites with or without comments, using meta description of the website or your own website description. You can share weblinks with users connected with you using LinkiBag account (your LinkiBag friends who have accepted your offer to connect), or you can email the weblink(s) and comments to anyone by entering any email addresses (those users will receive a link with the offer to review shared links and comments via email alone with Express Share ID – the number which could be entered into the specified place on LinkiBag webpage to access shared links). Web links, along with your comments (or a weblink to a generated LinkiBook), can be shared with other users via the link or by providing other users with a unique Share ID. Share ID will need to be entered into a specified box located in the header of the LinkiBag home page for users to access a shared website or shared LinkiBook. Shared weblinks sent to non-friends will expire within specified number hours and links will be available for specified number of hours from the time link was accessed.

Access to the Service and Advertising. We offer two types of accounts:

- paid accounts (free of advertisements) are available for both personal and commercial use, and
- free accounts (with supported advertisements) are for personal and non-commercial use only.

### **Notification to Account holders**

We collect your personal information such as your email address (which is used as your display name and shown to other users when you share links, communicate or collect with other users, use your account in any other way or format), phone number, city, state and zip code for US and Canadian users, and your interests from a form which is required to be completed by users using both free and paid accounts; users' activities such as clicks on advertisement links, times and dates a user accesses their profiles, the total number of saved weblinks and LinkiBook files, total number of friends; and user IP address, which is used to determine user's location such as city, state, zip code, and country using Google API Services.

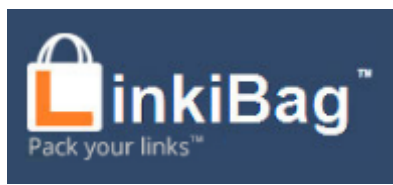
### **Notification to Free Account holders**

Free accounts are subject to and supported by advertisements. Advertisers are making their advertisement decisions by selecting the most appropriate group of users to be targeted with their advertisement. Advertisement includes, but not limited to placing links marked "AD" in users' mailboxes (up to 3 links per page located in the lower portion of your link list) with comments related to their business offer. For instance, Chicago-based Dental Office may be placing the link to their website with the comment stating the free offer for a dental check-up which will expire this month.

To make the right decision, our advertisers may have access to your information which does not identify you as a person. However, user email or user phone number will not be disclosed.

Nonetheless, advertisers may be able to learn about:

- 1) your interest selections marked on our interests form during the registration (for instance, advertiser may select only users interested in business, cooking, sports, etc.)
- 2) your location city, state and zip code entered during registration, and your location recorded at the time of your registration and/or last time you accessed LinkiBag website (for instance, advertiser may only select users from specific zip code, city, state, country, etc.)
- 3) users' activities such as last time of accessing LinkiBag, how much time you spent on the LinkiBag website, total number of friends, web links and LinkiBooks you have

- 4) your behaviour towards their ad (for example, if you have you seen the ad, have clicked on link details to read the message, and have opened provided weblink to provided website – possibly homepage of their company or the page with specific offer to sign up or to purchase the product or service).

Information on our paid account user is collected, but not shared with advertisers.

### **More details about Free accounts**

We don't charge you when you use this type of account. Free LinkiBag accounts are supported by advertisements, so businesses and organizations pay us to show you ads for their products and services. By using our free Service, you agree that we can show you ads that we think will be relevant to you and your interests. We use your personal data to help determine which ads to show you.

We don't sell your personal data to advertisers, and we don't share information that directly identifies you (such as your email address, phone number or other contact information) with advertisers unless you give us specific permission. Instead, advertisers can tell us things like the kind of audience they want to see their ads, and we show those ads to people who may be interested.

We provide advertisers with reports about the performance of their ads that help them understand how people are interacting with their content. Our Privacy Policy explains how we collect and use your personal data to determine some of the ads you see and provide all of the other services described below.

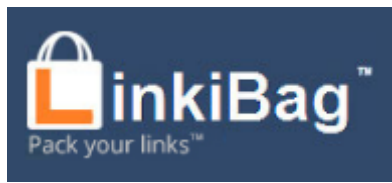
The User interest form is required to be completed by you when you register for your free LinkiBag account. Your phone number is required during registration and is not shared with advertisers and only used for authentication purposes of your account and to assist you if you forgot your login credentials (for example, if you forgot what email address you used to register).

We don't share information that directly identifies you (information such as your email address that by itself can be used to contact you or identifies who you are) unless you give us specific permission. We collect and use your personal data to provide the Services described above to you. You can learn about how we collect and use your data in our Privacy Policy.

### **General**

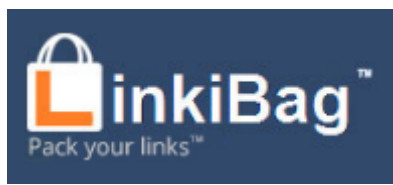

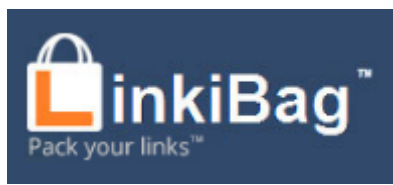
### **Applicable Use**
